III. general information on data processing

1. scope of the processing of personal data

We process personal data of our users, as far as this is necessary for the provision of a functional website as well as our contents and services. In addition, we process data (e.g. name, address, birth data, bank details, payment history) of our customers, prospects and business partners for the purpose of providing contractual services, service and customer care, marketing, advertising and market research.

2. legal basis for the processing of personal data

Insofar as we obtain the consent of the data subject for the processing of personal data, Art. 6 para. 1 lit. a EU Data Protection Ordinance (DSGVO) serves as the legal basis.

In the processing of personal data required for the performance of a contract to which the data subject is a party, Art. 6 para. 1 lit. b DSGVO serves as the legal basis. This also applies to processing operations that are necessary to carry out pre-contractual measures.

If processing is necessary to safeguard a legitimate interest of our company or a third party and if the interests, fundamental rights and freedoms of the data subject do not outweigh the first-mentioned interest, Art. 6 para. 1 lit. f DSGVO serves as the legal basis for processing.

3. data erasure and storage time

The personal data of the person concerned will be deleted or blocked as soon as the purpose of storage ceases to apply. Furthermore, data may be stored if this has been provided for by the European or national legislator in EU regulations, laws or other provisions to which the person responsible is subject. The data will also be blocked or deleted if a storage period prescribed by the aforementioned standards expires, unless there is a need for further storage of the data for the conclusion or fulfilment of a contract.

IV. Provision of the website and creation of log files

1. description and scope of data processing

Every time you visit our website, our system automatically collects data and information from the computer system of the calling computer.

The following data is collected:

- (1) Information about the browser type and version used
- (2) The user's operating system
- (3) The Internet service provider of the user
- (4) The IP address of the user
- (5) Date and time of access
- (6) Websites from which the user's system reaches our website
- (7) Websites accessed by the user's system via our website

The data is also stored in the log files of our system. This data is not stored together with other personal data of the user.

2. legal basis for data processing

The legal basis for the temporary storage of data and log files is Art. 6 para. 1 lit. f DSGVO.

3 Purpose of data processing

The temporary storage of the IP address by the system is necessary to enable the website to be delivered to the user's computer. For this the IP address of the user must remain stored for the duration of the session.

The data is stored in log files to ensure the functionality of the website. In addition, the data serves us to ensure the security of our information technology systems. An evaluation of the data for marketing purposes does not take place in this context.

Our legitimate interest in data processing pursuant to Art. 6 para. 1 lit. f DSGVO also lies in these purposes.

4 Duration of storage

The data will be deleted as soon as they are no longer necessary to achieve the purpose for which they were collected. In the case of the collection of data for the provision of the website, this is the case when the respective session has ended.

5. possibility of opposition and elimination

The collection of data for the provision of the website and the storage of data in log files is absolutely necessary for the operation of the website. Consequently, there is no possibility of objection on the part of the user.

V. Use of cookies

1. description and scope of data processing

Our website uses cookies. Cookies are text files that are stored in the Internet browser or by the Internet browser on the user's computer system. If a user visits a website, a cookie may be stored on the user's operating system. This cookie contains a characteristic character string that enables a unique identification of the browser when the website is called up again.

We only store the

(1) Log-in information,

(2) session ID

(3) Website on which the user was last located

2. legal basis for data processing

The legal basis for the processing of personal data using cookies is Art. 6 para. 1 lit. f DSGVO.

3 Purpose of data processing

The purpose of using technically necessary cookies is to simplify the use of websites for users. Some functions of our website cannot be offered without the use of cookies. For this it is necessary that the browser is recognized even after a page change.

4. duration of storage, possibility of objection and elimination

Cookies are stored on the user's computer and transmitted to our site. Therefore, you as a user also have full control over the use of cookies. You can deactivate or restrict the transmission of cookies by

changing the settings in your Internet browser. Cookies that have already been saved can be deleted at any time. This can also be done automatically. If cookies are deactivated for our website, it may no longer be possible to use all functions of the website in full.

2. legal basis for data processing

3 Purpose of data processing

The collection of the user's e-mail address serves to send the newsletter.

4 Duration of storage

In the course of the registration process, your consent is obtained for the processing of the data and reference is made to this data protection declaration.

3 Purpose of data processing

4 Duration of storage

The data will be deleted as soon as they are no longer necessary to achieve the purpose for which they were collected. The user's e-mail address will therefore be stored for as long as the subscription to the newsletter is active.

5. possibility of opposition and elimination

The subscription to the newsletter can be cancelled by the user concerned at any time. For this purpose there is a corresponding link in every newsletter.

c. Newsletter due to the purchase of goods or services

1. description and scope of data processing

It is possible to purchase goods and services on our website. Data from the input mask is transmitted to us.

In the course of the registration process, your consent is obtained for the processing of the data and reference is made to this data protection declaration.

In connection with the data processing for the dispatch of newsletters, the e-mail address is passed on to third parties, who in this context are subject to our strict instructions and with whom we are contractually bound. The data will be used exclusively for sending the newsletter.

2. legal basis for data processing

The legal basis for sending the newsletter as a result of the sale of goods or services is Section 7 para. 3 UWG.

3 Purpose of data processing

The collection of the user's e-mail address serves to send the newsletter.

4 Duration of storage

The data will be deleted as soon as they are no longer necessary to achieve the purpose for which they were collected.

5. possibility of opposition and elimination

The revocation about the receipt of newsletters can take place over a link in the newsletters themselves or by a message in text form (e.g. e-mail, fax, letter) to the contact possibility indicated in the imprint.

d. Newsletter for registered users of the website

1. description and scope of data processing

On our website you have to register as a user. Data from the input mask will be transmitted to us

In the course of the registration process, your consent is obtained for the processing of the data and reference is made to this data protection declaration.

2. legal basis for data processing

The legal basis for the processing of the data after registration for the newsletter by the user is Art. 6 para. 1 lit. a DSGVO.

3 Purpose of data processing

The collection of the user's e-mail address serves to inform them about further offers on the website and to be able to address them within the scope of community participation.

4 Duration of storage

The data will be deleted as soon as they are no longer necessary to achieve the purpose for which they were collected. The other personal data collected during the registration process will generally be deleted after a period of seven days.

5. possibility of opposition and elimination

The subscription to the newsletter can be cancelled by the user concerned at any time. For this purpose there is a corresponding link in every newsletter.

VII. newsletter tracking

1. description and scope of data processing

With the opening of a newsletter, a newsletter-related measurement of the reading behaviour in the newsletter begins. This tracking takes place anonymously without reference to the person of the user and his stored personal data.

2. legal basis for data processing

4 Duration of storage

5. possibility of opposition and elimination

This also makes it possible to revoke the consent to the storage of personal data collected during the registration process.

X. website analytics

a. Google Analytics suite

1. description and scope of data processing

We use the Google Analytics suite (Google Analytic, Google Tag Manager, Optimize, etc.), i.e. web analysis services of Google Inc. ("Google"), a web analysis service of Google Inc, (1600 Amphitheatre Parkway Mountain View, CA 94043, USA. Google has committed to comply with the EU-US Privacy Shield Agreement published by the US Department of Commerce on the collection, use and retention of personal data from EU member states. Google, including Google Inc. and its wholly owned subsidiaries in the United States, has been certified to comply with applicable privacy shield principles.

Google uses cookies (see V. Use of cookies). The information generated by the cookie about the use of the online offer by users is generally transferred to a Google server in the USA and stored there.

Google will use this information on our behalf to evaluate the use of our online offer by users, to compile reports on the activities within this online offer and to provide us with further services associated with the use of this online offer and Internet use. Pseudonymous user profiles can be created from the processed data.

We use the Google Analytics suite only with IP anonymization enabled. This means that Google will reduce the IP address of users within Member States of the European Union or in other states party to the Agreement on the European Economic Area. Only in exceptional cases will the full IP address be transmitted to a Google server in the USA and shortened there. The IP address transmitted by the user's browser is not merged with other Google data.
